

APPENDIX E 2018-2019 EQUALIZATION FORMULA

This Equalization Formula reports the number of ruling elder commissioners that each congregation in the presbytery is entitled to send to meetings of the presbytery for the period following adjournment of the June 2018 Stated Meeting and continuing until the June/July 2019 Stated Meeting adjourns.

The equalization formula has been prepared by the stated clerk in accord with G-3.0301 toward the goal of numerical parity for Ministers of Word and Sacrament and Ruling Elders who vote at meetings.

The number of ruling elder commissioners a congregation may send is listed below. Numbers are based on 12/31/17 membership as reported. Every congregation receives 2 commissioners plus an additional commissioner for every 250 members.

Congregations with the notation "RE" are non-ethnic congregations that have reported racial/ethnic elders and are invited to send a racial/ethnic elder commissioner (not an additional majority commissioner) in addition to those authorized by congregational membership in an effort to redress ethnic balance.
